MEIL Deploys Second TBM 'Arjuna' for Thane-Borivali Twin Tunnel Project

Mumbai, August 13, 2026 – Megha Engineering and Infrastructures Ltd (MEIL) has launched its second tunnel boring machine (TBM), 'Arjuna', for the Thane-Borivali Twin Tunnel Project. Maharashtra Chief Minister Devendra Fadnavis inaugurated the machine remotely from Sahyadri Guest House, setting it into operation at the Thane site. Deputy Chief Minister Sunetra Pawar, Chief Secretary Rajesh Agarwal, MMRDA Commissioner Sanjay Mukherjee, and Cabinet Ministers Mangal Prabhat Lodha and Girish Mahajan attended the launch. 'Arjuna' joins TBM 'Nayak', which began tunnelling in April, as MEIL accelerates work on the 11.84-km east-west corridor. Custom-built by German tunnelling specialist Herrenknecht, both machines feature 13.34-metre cutter heads and are the largest single-shield hard-rock TBMs deployed in India. The project will provide direct underground connectivity between Thane's Ghodbunder Road and Borivali's Western Express Highway, reducing travel time from 60–90 minutes to just 12–15 minutes. MEIL is executing the tunnelling beneath Sanjay Gandhi National Park with a design aimed at zero surface impact. The launch of 'Arjuna' marks another milestone for MEIL and MMRDA, bringing Mumbai closer to a faster, more sustainable cross-city connection.
